The license is non-transferable, is for the term of 365 days from January 1st to December 31st, and is revocable by the City of Anna in the event any of the representations of warranties herein above made are now or at any time are not true, or if applicant does in any way fail to comply with all applicable laws, rules, and regulations pertaining to the collection and disposal of waste.
