

**MINUTES OF THE REGULAR SESSION  
OF THE ANNA CITY COUNCIL  
OCTOBER 2, 2018**

The Anna City Council met in regular session at the Anna City Hall at 5:00 p.m. on October 2, 2018. The meeting was called to order by Mayor Steve Hartline. The roll call went as follows: Present were Commissioner Al Kamp, Commissioner David Isom and Commissioner Martha Webb and Mayor Steve Hartline. Commissioner Brandon Bierstedt was absent.

A motion was made by Commissioner Kamp and seconded by Commissioner Isom that it be **RESOLVED TO APPROVE THE OCTOBER 2, 2018 ANNA CITY COUNCIL REGULAR SESSION MINUTES AS SUBMITTED AS THE OFFICIAL MINUTES OF SAID MEETING.** A vote was taken upon the motion with the following results.
