### **BIG TRASH PICKUP**

The City of Anna is offering big trash pick up the week of January 4 - 6, 2022. All trash should be set out with your regular trash to guarantee pick up. ### **TRASH & RECYCLING INFORMATION**

On December 1, 2020 the Anna City Council passed Ordinance 2020-27; Regulating Trash Container Usage. Residents shall be allowed to place their allocated trash container(s) on the City street adjacent to their residence no earlier than 24 hours prior to, and removed no later than the end of, their scheduled trash collection day. ### **GAS DEPARTMENT INFORMATION**

If you think you smell gas it could indicate a leak. Evacuate the premises immediately, then contact Anna City Hall at 833-8528, after hours contact the Anna Police Department at 833-8571. Do not light a match; do not turn on an electrical switch or flashlight; do not use a telephone. An electrical arc may ignite the gas, causing an explosion.

### **IMPORTANT WEATHER INFORMATION**

The City of Anna strives to clear our streets and alley ways of snow and ice as soon as possible. Please remember that we do not plow private drives, which might include snow/ice left behind by plowing equipment.
