ORDINANCE 2020-27

AN ORDINANCE OF THE CITY OF ANNA REGULATING TRASH CONTAINER USAGE

THAT WHEREAS the Illinois Municipal Code empowers the City of Anna to make rules and regulations to protect and promote the health, safety and welfare of the City and its residents; and

WHEREAS the City of Anna has contracted with Republic Services to provide City residents with regularly scheduled trash collection services; and

WHEREAS, pursuant to the City of Anna's contract with Republic Services, trash containers have been allocated to Anna residents, which containers are to be placed on the City street adjacent to their residence for trash collection on specifically scheduled days of the week; and

WHEREAS, the Anna City Council, in order to carry out its duty of stewardship as delineated in paragraph one hereinabove, has determined that allocated trash containers should be placed upon and removed from City streets in a timely manner, and stored responsibly.

— NOW, THEREFORE BE IT ORDAINED:

ONE: That Anna residents shall be allowed to place their allocated trash container(s) on the City street adjacent to their residence no earlier than 24 hours prior to, and removed no later than the end of, their scheduled trash collection day.


TWO: That, except when being used as outlined in section ONE, each resident

shall keep their allocated trash container(s) immediately next to their dwelling, or inside a garage, shed or other such building which removes it from site.

THREE: Violations of this Ordinance shall subject the offending resident to fine(s) in conformity with City of Anna's Uniform Schedule of Fines.


FOUR: This Ordinance shall take effect immediately upon passage and publication as required by law.


