## MINUTES OF THE REGULAR SESSION OF THE ANNA CITY COUNCIL DECEMBER 15, 2020

The Anna City Council met in regular session at Anna City Hall at 5:03 p.m. on December 15, 2020. The meeting was called to order by Mayor Steve Hartline. The roll call went as follows: Present were Commissioner Michael Bigler, Commissioner Kathy Bryan, Commissioner Bryan Miller, Commissioner Martha Ann Webb and Mayor Steve Hartline. None were absent.

A motion was made by Commissioner Webb and seconded by Commissioner Bryan that it be <u>RESOLVED TO APPROVE THE DECEMBER 1, 2020 ANNA CITY COUNCIL REGULAR SESSION MINUTES AS THE OFFICIAL MINUTES OF SAID MEETING.</u> A vote was taken upon the motion with the following results. Commissioner Bigler, Commissioner Bryan, Commissioner Miller, Commissioner Webb and Mayor Hartline voted yea. Nay – none. Mayor Hartline declared the motion carried.

Discussion was held regarding the previously passed ERI Resolution. Kevin Clover presented a handout to each council member, which were copies of the letters they presented to City Administrator Dori Bigler regarding their requested retirement dates. Kevin stated that Mike Stegle requested April 29, 2021 and Steve Kelley, Bill Halter and himself requested April 25, 2022. Kevin stated the current resolution misses his retirement date by four months. He is requesting that the council consider revising the dates to the time span that was requested. Mike Stegle spoke in favor of the requested date change. Discussion was held regarding the ERI Program and the cost involved. Mayor Hartline stated the council will consider the request.

Treasurer Danyelle Dodd previously submitted the report for November 2020.

City Administrator Dori Bigler previously submitted project updates to the council. She reported that the Honor Wreaths were being delivered tonight.

A motion was made by Commissioner Miller and seconded by Mayor Hartline that it be <u>RESOLVED TO APPROVE RESOLUTION 2020-46</u>; <u>PROVIDING FOR THE TEMPORARY WAIVER OF FEES FOR CERTAIN CLASSIFICATIONS OF CITY LIQUOR LICENSE.</u> A vote was taken upon the motion with the following results. Commissioner Bigler, Commissioner Miller, Commissioner Webb and Mayor Hartline voted yea. Nay – none. Commissioner Bryan abstained. Mayor Hartline declared the motion carried.

A motion was made by Commissioner Bigler and seconded by Commissioner Bryan that it be <u>RESOLVED TO APPROVE A CHANGE ORDER #1 FOR MOTT EXCAVATION FOR THE WATERMAIN PROJECT IN THE AMOUNT OF \$4900.</u> A vote was taken upon the motion with the following results. Commissioner Bigler, Commissioner Bryan, Commissioner Miller, Commissioner Webb and Mayor Hartline voted yea. Nay – none. Mayor Hartline declared the motion carried.

No Bid received for the 2006 Chevy Impala. Commissioner Miller questioned if the vehicle could be donated. Discussion was held.

A motion was made by Commissioner Miller and seconded by Commissioner Bigler that it be <u>RESOLVED TO APPROVE TO DONATE THE 2006 CHEVY IMPALA</u>. Mayor Hartline declared the motion carried.

A motion was made by Commissioner Miller and seconded by Commissioner Bigler that it be <u>RESOLVED TO APPROVE POLICE OFFICER JEREMY RAEGAN AS SERGEANT EFFECTIVE DECEMBER 20, 2020.</u> A vote was taken upon the motion with the following results. Commissioner Bigler, Commissioner Bryan, Commissioner Miller, Commissioner Webb and Mayor Hartline voted yea. Nay – none. Mayor Hartline declared the motion carried.

A motion was made by Commissioner Webb and seconded by Commissioner Bigler that it be <u>RESOLVED TO APPROVE A BUILDING PERMIT TO RYAN</u> <u>DODD AT 100 PEACH DRIVE</u>. A vote was taken upon the motion with the following results. Commissioner Bigler, Commissioner Bryan, Commissioner Miller, Commissioner Webb and Mayor Hartline voted yea. Nay – none.
