TO INDEMNIFY AND SAVE HARMLESS THE CITY, ITS OFFICERS, AGENTS, SERVANTS AND EMPLOYEES FROM AND AGAINST ANY AND ALL SUITS, ACTIONS, LEGAL PROCEEDINGS, CLAIMS, DEMANDS, DAMAGES, COSTS, EXPENSES AND ATTORNEY'S FEES RESULTING FROM A WILLFUL OR NEGLIGENT ACT OR OMISSION OF THE LICENSEE, ITS OFFICERS, AGENTS, SERVANTS AND EMPLOYEES IN ITS PERFORMANCE OF SERVICES INCLUDING THOSE RESULTING FROM ANY PROCEEDING BY THE ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ARISING OUT OF LICENSEE'S COLLECTION OR DISPOSAL OF WASTE PURSUANT TO ITS LICENSE; PROVIDED, HOWEVER, THAT THE LICENSEE SHALL NOT BE LIABLE FOR ANY SUITS, ACTIONS, LEGAL PROCEEDING CLAIMS, DEMANDS, DAMAGES, COSTS, EXPENSES AND ATTORNEY'S FEES ARISING OUT OF A WILLFUL OR NEGLIGENT ACT OR OMISSION OF THE CITY, ITS OFFICERS, AGENTS, SERVANTS AND EMPLOYEES;
- (B.) TO SUPPLEMENT THE LIST OF NAMES AND ADDRESSES OF CURRENT CUSTOMERS WITHIN (10) OF ANY REQUEST THEREFOR BY THE CITY CLERK;
- (C.) TO NOTIFY THE CITY CLERK IMMEDIATELY UPON ANY CHANGE IN THE ANSWERS WHICH APPLICANT HAS MADE TO PARAGRAPHS (1.) THROUGH (7.);
- (D.) TO COMPLY IN ALL OTHER RESPECTS WITH THE TERMS AND PROVISIONS OF ORDINANCE NO. 92-10;
- (E.) THE LICENSE IS NON-TRANSFERABLE, IS FOR THE TERM OF 365 DAYS FROM THE DATE OF ISSUANCE THEREOF, AND IS REVOCABLE BY THE CITY OF ANNA IN THE EVENT ANY OF THE REPRESENTATIONS OF WARRANTIES HEREINABOVE MADE ARE NOW OR AT ANY TIME ARE NOT TRUE, OR IF APPLICANT DOES IN ANY WAY FAIL TO COMPLY WITH ALL APPLICABLE LAWS, RULES, AND REGULATIONS PERTAINING TO THE COLLECTION AND DISPOSAL OF WASTE.
