CITY OF ANNA MINUTES OF THE ZONING BOARD OF APPEALS OCTOBER 5, 2020

The Zoning Board of Appeals met in session at the Anna City Hall at 6:30 pm on October 5, 2020. The meeting was called to order by Chairman Rick Vicenzi. She stated that when she contacted Ameren regarding an address for electrical service, they indicated their files have the location addressed as 201 ½ E. Chestnut Street. Mr. Vicenzi asked Public Works Manager Gary Dahmer for his opinion. Mr. Dahmer stated that he feels we should allow the 40-foot set back. Mr. Lloyd questioned if the CILA Home has any objections. Ms. Wyatt stated that she has spoken to the owners and there are no objections. Mr. Miller questioned the alley way. Mr. Kelley questioned the property lines. City Attorney John Foley stated that the issue is the front setback and that the Union County Tax bill has the address listed as 101 ½ E. Chestnut. Ms. Wyatt stated it is located in the 200 block and she thinks it needs to be 201 ½ E. Chestnut Street.
