### **REGULAR TRASH REMINDER**

### **REMINDER**

Anna City Code Section 33-2-19 prohibits the discharge of cut grass, leaves and/or other debris on public streets within the city. Any person who violates this ordinance shall be given a written warning upon the first offense. Subsequent offenses shall be punishable by a fine of up to \$250, as well as clean-up cost and attorney fees when applicable.

### **TALL GRASS/WEED REMINDER**

Anna City Code Section 25-2-2 regulates and provides for the abatement of tall grasses/weeds which constitute public nuisances. If found in violation of this ordinance, you may be subject to fine(s) and/or lien(s) against your property.
