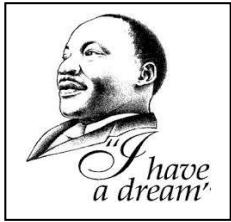

BIG TRASH PICKUP

The City of Anna is offering big trash pick up the week of January 7-9, 2025. All trash needs to be set out with your regular trash to guarantee pick up. GAS DEPARTMENT INFORMATION

If you think you smell gas it could indicate a leak. Evacuate the premises immediately. Then contact Anna City Hall at 833-8528, after hours contact the Anna Police Department at 833-8571. Do not light a match; do not turn on an electrical switch or flashlight; do not use a telephone. An electrical arc may ignite the gas, causing an explosion.
