**AN ORDINANCE BY THE CITY COUNCIL OF ANNA, ILLINOIS, ADOPTING AN ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING MAY 1, 2019 AND ENDING ON APRIL 30, 2020.**

WHEREAS, the City of Anna has adopted Section 8-2. 1, et seq., of the Illinois Municipal Code, providing for passage of an Annual Budget in lieu of passage of an Appropriations Ordinance, and heretofore appointed a Budget Officer: and,

WHEREAS, the Budget Officer has prepared and compiled a Tentative Annual Budget which has been presented to the City Council: and,

WHEREAS, the City Council did by Resolution No. 2019-03 provide for making the Tentative Budget conveniently available for public inspection at least 10 days prior to the passage of the Ordinance, both by attachment to the Resolution, publication in the journal of proceedings of the Council, and by publication by placement on the bulletin board available to the public in the public area in the Anna City Hall, 103 Market, Anna, Illinois, commencing March 7, 2019.

WHEREAS, there was given notice by publication in the Gazette-Democrat, a newspaper having general circulation in the Municipality, on March 7, 2019, which was at least one week prior to the time of hearing on the Tentative Annual Budget, which notice was in words and figures as follows:
