- 1.) CUSTOMER AGREES TO PAY A **TAP FEE OF \$500.00 FOR EACH SERVICE RUNS THAT ARE INSIDE CITY LIMITS, CUSTOMER AGREES TO PAY A TAP FEE OF \$650.00 FOR EACH SERVICE RUNS THAT ARE OUTSIDE CITY LIMITS.** TAP FEE INCLUDES MAKING TAP, MATERIAL AND LABOR UP TO 100 FEET OF LINE. IN THE EVENT THAT MORE THAN 100 FEET OF LINE IS REQUIRED, CUSTOMER AGREES TO PAY AN ADDITIONAL PRO RATA AMOUNT FOR THE EXTRA FOOTAGE. THIS APPLIES TO TAPS THAT ARE ¾ OR 1 INCH.
- 2.) ALL TAPS MORE THAN 1 INCH WILL BE CHARGED TAP FEE PLUS COST OF MATERIALS ON A PER JOB BASIS.
- 3.) ALL NEW SERVICES ARE REQUIRED, BY THE I.C.C., TO HAVE AN EXCESS FLOW VALVE (EFU) INSTALLED.
- 4.) TO USE THE SERVICE, AND TO PAY THE RATES AND CHARGES FOR SERVICES, ALL IN THE MANNER AND AMOUNTS FROM TIME TO TIME IN EFFECT AND ESTABLISHED BY THE CITY.
- 5.) TO GRANT THE CITY THE RIGHT TO USE THE PREMISES FOR THE PURPOSE OF CONNECTION TO THE SERVICE AND PROVIDING SERVICE TO THE PREMISES.
- 6.) NOT TO CONTEST THE CITY'S OWNERSHIP OF ANY APPURTENANCES OR CONNECTIONS TO THE SERVICE.
- 7.) TO RELEASE THE CITY FROM ANY LIABILITY FOR ITS FAILURE TO PROVIDE OR MAINTAIN CONTINUOUS SERVICE AT ANY PARTICULAR TIME BEFORE OR AFTER SUCH CONNECTION IS FEASIBLE.
- 8.) TO GRANT AND DOES HEREBY GRANT, TO THE CITY EMPLOYEES, ACCESS TO PERMISES AT ALL TIMES FOR THE PURPOSE OF READING METERS, TESTING, REPAIRING, REMOVING OR EXCHANGING ANY OR ALL CITY EQUIPMENT OR FIXTURES.
