MINUTES OF THE REGULAR SESSION OF THE ANNA CITY COUNCIL SEPTEMBER 17th, 2024

The Anna City Council met in regular session at Anna City Hall at 5:00 p.m. on September 17th, 2024. The meeting was called to order by Mayor Steve Hartline. The roll call went as follows: Present were Mayor Steve Hartline, Commissioner Michael Bigler, Commissioner Kathy Bryan, Commissioner Torie Carter, and Commissioner Martha Ann Webb. Other members present were City Administrator Dori Bigler, Treasurer Angela Webb, and Public Works Director Gary Dahmer.

Mayor Hartline opened the floor to the public communications portion of the agenda.

City Administrator Dori Bigler gave updates on the upcoming Walk and Roll to School Day. Anna PD and Public Works are volunteering to help with crossing guard duties for the day. PARC and Davie St Projects are moving along. Davie Street project has raised \$257,000 in sponsorships! We are under contract for the Reppert garage. The ITEP application was submitted today. Finally, we have a third option to present for the West Davie Street parking lot.
