

**MINUTES OF THE REGULAR SESSION
OF THE ANNA CITY COUNCIL
SEPTEMBER 16TH, 2025**

The Anna City Council met in regular session at Anna City Hall at 5:00 p.m. on September 16th, 2025. The meeting was called to order by Mayor Steve Hartline. The roll call went as follows: Present were Mayor Steve Hartline, Commissioner Michael Bigler, Commissioner Kathy Bryan, Commissioner Torie Carter and Commissioner Martha Ann Webb. Other members present were City Administrator Dori Bigler and Treasurer Angela Webb.

Mayor Hartline opened up the meeting to the public communications portion of the agenda.

Mayor Hartline recognized Greg Harris for his accomplishments as an umpire. He was one of sixteen chosen to umpire the 1A and 2A IHSA State Championship. Mr. Harris was unable to attend the meeting due to conflicts.

City Administrator Bigler gave an update on the Plaza project and a few projects in the works.
